



FREEDOM OF INFORMATION POLICY

The Freedom of Information Law, which took effect on January 1, 1978, gives you the right of access to many public records. Elmwood Village Charter School has adopted a policy governing when, where, and how you can see public records. The policy can be seen at all places where records are kept.

1. Designation of Records Access Officer

- (a) The Board of Trustees is responsible for insuring compliance with the Freedom of Information Law, and designates the following person(s) as records access officer(s):

3. Denial of access to records

- (a) Denial of access to records shall be in writing stating the reason therefor and advising the requester of the right to appeal to the Board of Trustees.
- (b) If requested records are not provided promptly, as required in Section 6, such failure shall also be deemed a denial of access.
- (c) The Board of Trustees shall determine appeals regarding denial of access to records under the Freedom of Information Law:
- (d) Any person denied access to records may appeal within thirty days of a denial to:

4. Family Education Rights and Privacy Act: The School will not disclose any information from a student's permanent record except as authorized pursuant to the Federal Education Rights and Privacy Act or in response to a subpoena as required by law. The parents or guardians of a student under the age of 18 years of age, or a student 18 years of age or older, are entitled to access to the student's school records by submitting a written request to the school leader.

The school maintains a reasonably detailed current list, by subject matter, of all records in the school's custody or possession.
